FAMILY LAW

COURSE DESCRIPTION AND OBJECTIVES: To provide students with a basic foundation of knowledge regarding the legal implications of family and interpersonal relationships. This course includes a study of common law and statutory concepts of family relationships, including, but not limited to: family privacy, procreation, marriage, premarital agreements, divorce, marital property, alimony, annulment, child custody, visitation and support, education, adoption, and domestic violence.

TEXT: FAMILY LAW- Cases and Materials (5th Edition), Judith Areen and Milton C. Regan, Jr.

COURSE REQUIREMENTS: All requirements will be weighted equally.

Examinations: Three (3) examinations will be given. Each exam is worth 100 points.

Case Briefs: All assigned cases must be thoroughly briefed. One (1) case will be assigned as a briefing exam, worth 75 points. A briefing format will be disseminated by the instructor.

Student Participation: Student participation in class will be graded and assigned a total point level of 25 points.

3. MAKE-UP EXAMINATIONS AND LATE WORK: Upon the occurrence of serious illness or other circumstances, supported by appropriate documentation, i.e. that from a physician, clinic, or hospital, one make-up examination may be given. More than one will never be given. Late work is not accepted. Deadlines are announced at least two (2) weeks in advance, if not earlier. Therefore, late work will not be graded. If you foresee a problem, make sure all assignments are turned in prior to the deadline.
