NARRATIVE 2018 BUDGET REQUEST

Univ of Southern Mississippi - Gulf Coast Research Lab (443-00)

Name of Agency

The Gulf Coast Research Laboratory (GCRL) is administered through the University of Southern Mississippi's College of Science and Technology (COST). Focused on advancing the knowledge and technology needed to understand and responsibly use and sustain Mississippi's marine and coastal resources, the GCRL is a robust and growing research, education, and outreach enterprise. The State appropriation is critical for leveraging more than \$8 million support annually from federal agencies and other sources. GCRL units and programs are located at two sites in Ocean Springs:

* the original 50-acre site on Halstead Road

* the Cedar Point site adjacent to the Gulf Islands National Seashore

The Halstead Road site is adjacent to the Mississippi Sound and is surrounded by bayous and salt marshes that provide a natural laboratory for researchers and students. The site's buildings house research and teaching laboratories, classrooms, and offices where researchers, technical and support personnel, and graduate and undergraduate students work. Three of GCRL's four core research and academic units are located at Halstead Road: the Center for Fisheries Research and Development, the Department of Coastal Sciences, and the Marine Education Center, which includes the GCRL Summer Field Program. The GCRL Museum and Ichthyological Research Collection has recently been incorporated into the Department. Key support units at Halstead Road include the Gunter Library, Business Office, Vessel Operations, External Relations, and iTech support.

The 224-acre Cedar Point site is still under development with 16 buildings completed and currently in use. The site houses the main GCRL Physical Plant support complex and the fourth of GCRL's primary research and academic units, the Thad Cochran Marine Aquaculture Center. This Center utilizes bio secure facilities for the expansion of marine aquaculture using recirculating systems developed by GCRL. Construction of the new multi-building Marine Education Center, which has been temporarily relocated at the Halstead Road site since Hurricane Katrina, is underway at Cedar Point with an anticipated completion for Fall 2017. The Katrina-damaged Toxicology Building is on schedule for completion in Spring 2017 at Cedar Point.

Point Cadet in Biloxi is also the docking and staging area for GCRL's 97-foot research vessel, the R/V Tommy Munro.

FY 2018 Needs Assessments

1. Research and academic growth at GCRL has resulted in increased laboratory operations and associated maintenance and safety management needs. Restoring funding to FY16 appropriation balances will provide needed resources to safely manage and maintain laboratories through training and additional staffing.

2. A recent review of physical plant staffing found GCRL to be "significantly understaffed and underfunded" relative to other academic institutions of its size according to Association of Physical Plant Administrators (APPA) guidelines and unable to prevent continuing deterioration of its physical plant. The construction of multiple new buildings at the GCRL Cedar Point site will also require additional physical plant support. The restoration of funds to FY16 appropriation balances will help to close this gap on funding needs for additional physical plant personnel.

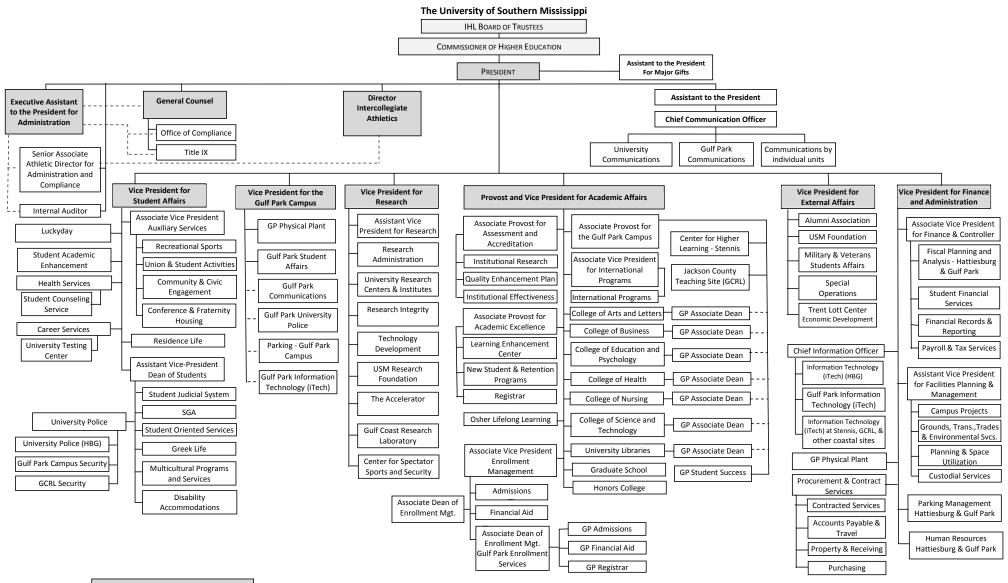




