I am a social work educator, a group therapist expert and Gestalt therapist specializing in war-related trauma and personal awareness. I have a distinguished national and international reputation in Posttraumatic Stress Disorder (PTSD) as a clinician/manager, innovative therapy and program developer, educator, and research and publishing record to include war-related trauma, post-disaster interventions, race-related trauma and exposure-and experientially-based therapy. I have been in 300+ media (60 Minutes, Nightline, PBS, NPR, *New York Times*, *Washington Post*, etc.) and speaking presentations internationally, nationally, regionally and locally.

I have led critical stress briefings (natural disasters, hostage incidents, corporate downsizing), to include co-coordinating three-month deployment of VA CISD teams to the island of Kauai (Hawaii) for mental health disaster relief in the aftermath of Hurricane Iniki; trained as a member of the Honolulu Police Department CISD back-up team; and initiated substantial post-Katrina counseling services and community education presentations in Mississippi to University faculty, staff and students, and community and professional groups.

Other areas of expertise: compassion fatigue educator/therapist; teaching and assessing how to give professional presentations; 1-1, family and peer-group therapy; psychiatric and social work assessments; outreach; clinician-to-administrator transition; community-based mental health; therapeutic communities; dual disorders; supervision; task-group processing and strategic planning.

A meditator since 1977, I completed advanced meditation Siddha training, and am knowledgeable of Far East and Middle East cultures, music and cuisine through family heritage (Arab-American), interests and travel.
