# Child's Policy

## “Child Defined”

Anyone 15 years of age and younger.

## Eligibility for Admittance

- Must be dependent of a REC cardholder
- Dependents of a guest must also purchase a guest pass
- Children who are not dependent of the REC cardholder must also purchase a guest pass

## - Supervision

While in the Payne Center, a child must be supervised and remain with an adult at all times.

(\*an exception is made for use of the Natatorium)

## User Fee

- All dependent children of a REC cardholder will be admitted free of charge
- Adult guests and non-dependent guests must pay a user fee of \$10.

## Participation Policy

Children may use the first floor area of Payne Center during the following periods:

- Any Friday beginning at 5 p.m. (fall and spring)
- Saturdays and Sundays (anytime)
- Any weekday during summer semester, semester breaks and holiday break

## Area Policies

Program activities may restrict access to specific areas.\*

No one under the age of 16 is allowed on the second floor of the Payne Center. Atrium

- An adult must supervise and remain with the child at all times. Children are not to be left unattended. Racquetball and Squash Courts
- Children over the age of 12 and with the adult supervision at all times. Gymnasium
- No age restrictions, but the child must be supervised.

M.C. Johnson Natatorium\*

- For children 11 years of age and under, an adult must supervise and remain with the child at all times in the Natatorium.
- For children 12 years of age and older, the adult may leave the Natatorium provided the child passes the swim test given by the lifeguard, but the adult must remain in the Payne Center at all times.

Locker Rooms

- Due to concerns for our patron's children and the privacy of other patrons, we have established the following policy: Female patrons may not take a male child into the women's locker room at any time. Likewise, a male patron may not take a female child into the men's locker room at any time. If you need assistance concerning your child, please contact facility management at the Welcome Center.

\*Special Note:

During special events (e.g., summer camps, Premier, Black & Gold Day, etc.), a child may be allowed into the Payne Center, as a spectator, with adult supervision. The child is restricted to the area in which the event is held and must remain with the adult at all times.
